Ordinance 21-05 Business License Standardization Ordinance, First Reading by Title

Clerk/Treasurer Randee Beasley reviewed the ordinances 21-04 and 21-05. The ordinance is needed due to the Business License Standardization act that was passed by the state. MASC wrote the model ordinance in which we are using. Once this ordinance is passed, we will be in compliance with the new laws. Ms. Beasley did state that after the MASC reviewed the current rates, the Town would need to adjust so that we are revenue neutral.

Ms. Rappley did not show up to the meeting, however, Ms. Beasley explained to council the conversation, she had with Ms. Rappley.

Ms. Rappley and, son, Travis Shell's intentions are to open an arcade/lounge along the lines of Dave and Busters. She asked to be on the agenda so that she could get Councils advise as to whether or not the business could be opened.

Mayor Horne stated that Ware Shoals needs some kind of night life, but would be cautious given previous history with other business Ms. Rappley's son has had in town.
